## IMPORTANT SAFETY AND HANDLING INFORMATION

Read the following warning before you or your child play with the BrainLink. Failing to do so may cause injury.

**CAUTION:** To reduce the risk of damage or injury, do not attempt to disassemble BrainLink. No user-serviceable parts are contained inside.

## General

- Read all safety and operating instructions before **operating BrainLink**.
- Retain the safety and operating instructions for **future reference**.
- Follow all operating and use instructions.
- Do not attempt to service BrainLink yourself. Refer all **non-routine** servicing to Macrotellect.

## Seizure, Blackouts and Eyestrain

A small percentage of people may be susceptible to blackouts or seizures (even if they have never had one before ) when exposed to flashing lights or light patterns such as when playing games or watching video. If you have experienced seizures or blackouts or have a family history of such occurrences, you should consult a physician before playing video games or watching videos. Discontinue use of BrainLink and consult a physician if you experience headaches, blackouts, seizures, convulsion, eye or muscle twitching, loss of awareness, involuntary movement, or disorientation. To reduce risk of headaches, blackouts, seizures and eyestrain, avoid prolonged use, hold your smart device some distance from your eyes, use BrainLink in a well-lit room, and take frequent breaks.

## Repetitive Injury

When you perform repetitive activities such as playing games on your smart device, you may experience occasional discomfort in your hands, arms, shoulders, neck, or other parts of your body. Avoid excessive play. It is recommended that parents monitor their children for appropriate play. Take frequent breaks and if you have discomfort during or after such use, stop use and see a physician.



**WARNING: Choking Hazards** BrainLink has small parts inside its shell, which may present a choking hazard to small children and pets. Keep BrainLink and its accessories away from small children.

## Keeping BrainLink Within Acceptable Temperatures

Operate and store BrainLink in a place where the temperature is between 0° and 30° C (32° to 90° F). Low—or high—temperature conditions might temporarily shorten battery life or cause BrainLink to temporarily stop working properly. Avoid dramatic changes in temperature or humidity when using BrainLink in your car, because temperatures in parked cars can exceed this range. When you're using BrainLink or charging the battery, it is normal for BrainLink to get warm. The exterior of BrainLink functions as a cooling surface that transfers heat from inside the unit to the cooler air outside.

## Use and Maintenance

BrainLink is not suitable for use by children under 3 years of age.

### Never:

Abuse ,throw, drop, puncture, violently kick or step on BrainLink. This can damage the robot and compromise its safe operation.

### Always:

Periodically examine BrainLink for potential hazards such as cracked, damaged or otherwise broken parts. In the event of such damage, do not use BrainLink until it can be replaced or repaired.

## Battery Warning

- Lithium Polymer batteries are **extremely hazardous and liable** to cause serious injuries to persons or property. **The user accepts liability** for the use of a Lithium Polymer battery. As the **manufacturer and the distributor** cannot ensure the battery is used correctly (**charging, discharging, storage, etc.**), they cannot be held liable for damages caused to **persons or property**.
- In the event of battery leakage, avoid the **liquid coming into contact** with skin and eyes. In case of contact with the skin, **wash copiously with soap and water**. ## Charging

- Recharge the battery at a temperature of between 0 and 30(32 to 90F).

## Use and storage

- Do not use the BrainLink if the cover has been broken and the battery's plastic cover has been cracked or compromised in any way.
- Do not expose the battery to excessive physical shock.
- Do not expose BrainLink and its battery to heat or dispose of a fire.
- Do not put BrainLink and its battery in a microwave oven or in a pressurized container.
- Do not attempt to dismantle, pierce, distort or cut the battery and do not attempt to repair the battery. Do not place any heavy objects on BrainLink or the battery.
- It is essential to avoid short circuits. Avoid direct contact with the electrolyte contained within the battery. The electrolyte and electrolysis vapors are harmful to health.
- Do not subject BrainLink and its battery to large temperature variations. Do not place your BrainLink near a source of heat.

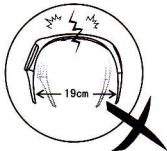
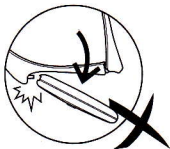
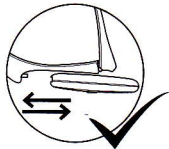
